

**MINUTES OF THE REGULAR MEETING
COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA
April 20, 2022**

Call to Order: Mayor Snedecor called the meeting to order at 6:00 p.m. followed by the Pledge of Allegiance, and moment of silence. The meeting was held with the building open to the public and a call-in number for remote public participation.

Roll Call: The following members were present in person: Mr. Kopil, Mr. Huddlestun, Mr. Maggio, Mr. Vinzant, Mr. Claussen and Mr. Waldrop. Absent (representing the Council at the Little Cal River Basin Commission meeting): Mr. Wells. Also present: City Attorney McCarthy and Clerk-Treasurer Longer.

Reading of the Minutes: Motion by Mr. Kopil, seconded by Mr. Claussen, to approve the Minutes of the Regular Meeting of April 6, 2022 and the Memorandum of Executive Session of April 6, 2022, as presented. All aye, motion carried. (6-0)

Correspondence: There was no correspondence.

Committee Reports: Mr. Kopil noted that many of the Councilmen met in a joint work session with the Sanitary District Board to discuss needed upgrades to the Main Lift Station and the Force Main to GSD. He stated these upgrades will require a large financial obligation. Mr. Vinzant stated the HSD has funding options available to them that they are looking into for these projects.




