

**MINUTES OF THE REGULAR MEETING OF
THE HOBART CIVIL SERVICE FIRE COMMISSION
OF THE CITY OF HOBART
HELD SEPTEMBER 8, 2020 at 6:00 p.m.**

Call to Order: Mr. Lamprecht called the meeting to order at 6:00 p.m., followed by the Pledge of Allegiance and a moment of silence for deceased First Responders. The meeting was held with the building open to the public and a call-in number for remote public participation.

Roll Call: The following members were present: Mr. Lamprecht. Also present: Secretary Cheryl Govert, Attorney Mindel and Chief Smith. Mr. Schallenkamp was present telephonically. Absent: Mr. Finnerty.

Approval of the Agenda: Motion by Mr. Lamprecht, seconded by Mr. Schallenkamp, to approve the agenda as presented. All aye, motion carried. (2-0)

Update: Promotion Examination: Mr. Lamprecht noted that the test is scheduled for September 9th at 7 pm. Mr. Lamprecht said that 3 will test for Captain, 1 for Fire Prevention, and 2 for EMS Director. The list will be certified at the October meeting. Mr. Lamprecht also noted that 4 names remain on the Lieutenant list which expires July 2021.

Update: Lateral Transfer Candidate Testing: Mrs. Govert said that 5 applications were received and turned over to Mr. Lamprecht. Mr. Lamprecht noted that all the applicants meet the criteria and are all members of the 77 Fund. The written exam will take place at 9 am at Fire House 1 on September 29th and 30th and a list can be certified at the October 14th meeting of the Fire Commission. Mrs. Govert will send letters to the applicants advising them to call Mr. Lamprecht to schedule their exam.

Discussion was held about allowing Lt. Pouch to take the Captains test as he is just 2 weeks from the 2-year qualification. Motion by Mr. Schallenkamp, seconded by Mr. Lamprecht, to allow Lt. Pouch to take the Captain exam on September 9, 2020. All aye, motion carried. (2-0)
