

50-50 SIDEWALK PROGRAM 2019
PARTICIPANT INFORMATION & APPLICATION

Information page for reference

The 50/50 Sidewalk Program is for *public sidewalks only*.

There is no maximum to the amount of sidewalk that can be replaced. However, **three adjacent squares** (a square being the portion of sidewalk between expansion joints) is the **minimum amount of sidewalk that can be replaced**.

In addition, owners will not be permitted to have one square remain in place while the squares on each side of it are replaced, the one square would be included in the replacement.

If the application amounts exceed funding availability, the City of Hobart retains the right to prioritize applications.

If the sidewalk being replaced intersects another sidewalk or driveway that has shifted, raised or sunk, the owner will be required to replace a minimum length of one-foot of the intersecting piece so as not to create a public safety hazard. The one-foot area will merge the correct grade of the new sidewalk and the incorrect grade of the intersecting piece, eliminating any tripping hazards. If the intersecting piece lies within the owner's private property or a driveway apron, the cost will be shared equally between the owner and the City of Hobart and shall be included in the Repair Agreement and the owner's payment to the City. Said intersecting piece lying within the owner's private property or driveway apron shall become a part of the contractor's awarded scope of work and is part of the shared agreement with the City to ensure public safety is maintained. If more than one-foot of the property owner's sidewalk is desired to be replaced, the property owner, at his/her expense and discretion, may perform the work or hire a contractor to complete the private property portion of the work.
