Resolution 2022-15: A Resolution Preliminarily Determining to Issue General Obligation Bonds of the City of Hobart, Indiana

Ordinance 2022-36: (*1st Reading Only*) An Ordinance Authorizing the Issuance of Bonds for the Purpose of Providing Funds to be applied to Reimbursing the City for certain Capital Expenditures previously incurred and to pay all incidental expenses in connection therewith and on account of the Issuance of the Bonds

Ordinance 2022-40: An Ordinance Transferring Appropriations within the 2022 Budget of the General Fund, Fire Department.

Ordinance 2022-41: An Ordinance Amending the Municipal Code of the City of Hobart to Provide for Fees and Charges for Certain Municipal Services and Activities
