

ORDINANCE 2022 - 35 As Amended

AN ORDINANCE AMENDING ORDINANCE 2022-24 and ORDINANCE 2022-25 OF THE COMMON COUNCIL BY AMENDING CERTAIN SALARIES FOR FULL-TIME POLICE AND FIRE SWORN PERSONNEL COMMENCING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023

WHEREAS, the Common Council ("Council") of the City of Hobart, Lake County, Indiana adopted Ordinance 2022-24 and 2022-25 fixing the salaries of Police Department Sworn Personnel and Firefighter Sworn Personnel respectively in the City of Hobart for Fiscal Year 2023 on September 7, 2022; and

WHEREAS, the City of Hobart has recently been advised that salary rates for positions in the Police and Fire Departments for sworn personnel have made it difficult to recruit and retain individuals for these public safety positions; and

WHEREAS, the Council, having been advised of these compensation issues and the need to recruit new officers and firefighters for the City of Hobart, now desires to amend Ordinance 2022-24 and Ordinance 2022-25 regarding certain positions for Police and Fire Sworn Personnel compensation to bring them more in line with the surrounding area in order to recruit and retain the personnel needed;

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION ONE: That Ordinance 2022-24 for the Police Department Sworn Personnel be amended as follows:


and deleting **Section 1(a): FY 2023 Additional Compensation** in its entirety.






