A Resolution to Name the  
3<sup>rd</sup> Street Bridge over Lake George  
in Honor of  
Mayor Brian K. Snedecor

WHEREAS, Brian K. Snedecor serves as the Mayor of the City of Hobart from 2008 through 2023 and to date, has been the longest serving Mayor in the history of Hobart, having been elected to four consecutive terms; and

WHEREAS, Mayor Snedecor also served on the Hobart Police Department from 1980 through 2007, holding the office of Chief of Police from 2001 through 2006 before retiring and being elected as Mayor for his first term; and

WHEREAS, Mayor Snedecor, as a resident of the City of Hobart, and has been active in many local organizations throughout the years, including: Trade Winds, Hobart Kiwanis, Hobart Lion's Club, Hobart Rotary, Hobart Chamber of Commerce, Northwestern Indiana Regional Planning Commission (NIRPC), One Region-One Vision, and the Northern Regional Mayor's Roundtable; and

WHEREAS, Mayor Snedecor, during his tenure in office, enabled numerous projects including: rehabilitating the old Hobart Middle School into the City's Police/Court/Community Complex, rebuilding of the Hobart Parks Community Center, upgrading of Fire House #2, establishing the Maria Reiner Senior Center, upgrading the Hobart Pool, developing trail connections throughout the City, construction of a CNG fuel fill station and implementing a CNG fleet acquisition program; and


WHEREAS, Mayor Snedecor is a dedicated servant to the City of Hobart and a thoughtful and beloved friend by many residents of the City; and

WHEREAS, Mayor Snedecor was, among many other things, instrumental in the design and construction of the 3<sup>rd</sup> Street Bridge, widening and raising it to allow larger recreational water vessels access to the Lake Front Park portion of Lake George and improving the stormwater flow through Hobart as part of the Deep River Watershed and the greater Little Calumet Watershed; and


WHEREAS, the Common Council of the City, being mindful of all of Brian Snedecor's service to his City, and desiring to recognize his service and name the honor it is due;

Snedecor 3<sup>rd</sup> Street Bridge over Lake George."


