

COMMON COUNCIL OF THE CITY OF HOBART, INDIANA

ORDINANCE NO. 2024 - 38

An Ordinance Amending the Municipal Code of the City of Hobart to Amend Fees and Charges for Certain Municipal Park and Recreation Services and Activities

WHEREAS, the Common Council ("Council") of the City of Hobart ("City") has been advised that some of the fees and charges previously established and contained in the Municipal Code of the City for the Park Department are no longer sufficient to defray the actual costs of administering the various services and administrative activities related to them; and

WHEREAS, Park Board of the City has proposed new fees or fee amendments sufficient to support the operational and administrative activities of the Departments measured by their true cost of operating said functions; and

WHEREAS, the Council has received said proposals and has considered same, and now desires to make its determination of new Park and Recreation fees effective and to spread same upon the public record through this Ordinance.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Indiana as follows:

SECTION ONE. The Fee Schedule for the City of Hobart is hereby amended by adding new fees or amending current fees related to the Park & Recreation Department specified as follows: (Items in bold italic are changes to current schedule)

Community Center Rentals (Festival Park)

Must cancel 60 days before event to get a refund.

Rental Rates are for private use of park facilities

Deposit Required: \$200

Day Rental 10 am - 6 pm (including cleaning):

Resident: \$400 \$500 / Non-Resident: \$500 \$700

Night Rental 10 am - 12 midnight (including cleaning):

Resident: \$600 \$700 / Non-Resident: \$700 \$900

Political Parties: \$150 (including cleaning)

Not for Profit Parties 10 am – 10 pm (including cleaning): \$200 \$250

Meeting Rate (4 hours 2 hours-No Food): Resident: \$150 \$75 / Non-Resident: \$200 \$100

Security (issued by Hobart Police Dept): \$125 \$200 for 5 hours if alcohol is being served

Licensed Bartender (issued by Hobart Park Dept.): \$75 \$100

25% Military discount available (only off of the actual hall rental fee)

Other Rentals (Fields lined and prepared for game rentals only.)

Bandshell or Gazebo: 2 hours: Resident: \$40 / Non-Resident: \$50

All Day Dawn to Dusk: Resident: \$100 / Non-Resident: \$150

Park Shelters: 2 hours: Resident: \$40 / Non-Resident: \$50

PCC Community Gym: Resident: \$300 / Registered Non-Profit: \$200

Resident: \$300 / Registered Non-Profit: ~~\$150~~ **\$200** (Electric \$50 Addtl.) **(no electric)**

Non-Profit Gym Rental **10am-10pm All day** (must be registered non-profit): ~~\$150~~ **\$200**

Resident Party Package 10am-10pm (includes Party Room & Gym): ~~\$250~~ **\$300**

Non-Resident Party Package 10am-10pm (includes Party Room & Gym): ~~\$350~~ **\$400**

Resident Gym Rental for ~~3 hours~~ **2 hours**: ~~\$75~~ **\$80**

Non-Resident Gym Rental for ~~3 hours~~ **2 hours**: ~~\$125~~ **\$120**

Non-Profit Gym Rental for ~~3 hours~~ **2 hours**: ~~\$30~~ **\$40**

Non-Profit Party Package All day 10am-10pm (includes Party Room for food and Gym): \$250

Resident Meeting Room (no food): \$40 for 2 hours

Non-Resident Meeting Room (no food): \$80 for 2 hours


Food Sale Permit in Parks

Park locations and dates must be approved first – current market fee charges will apply.

SECTION TWO: This ordinance and the fees it sets out shall become effective January 1, 2025.

SECTION THREE: All other ordinances or portions thereof in effect prior to the effective date and in conflict with the provisions of this ordinance are hereby repealed.

ALL OF WHICH is PASSED and ADOPTED by the Common Council of the City of Hobart, Indiana on this 16th day of December, 2024.






