

ORDINANCE 2025 - 18

AN ORDINANCE AMENDING ORDINANCE 2024-23 OF THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA, AMENDING THE HOURLY COMPENSATION RANGE FOR CERTAIN PART TIME EMPLOYEES OF THE HOBART PARK AND RECREATION DEPARTMENT

WHEREAS, the Common Council ("Council") of the City of Hobart, Lake County, Indiana adopted Ordinance 2024-23 fixing the salaries of officers and employees of the City of Hobart for Fiscal Year 2025 on September 4, 2024; and

WHEREAS, the City of Hobart has recently been advised that the pay rate range for Event Security, as part-time position for Hobart Park Department have made it difficult to secure available security as needed on a part-time basis and the cost of living increases has not matched the sacrifices made for the part-time work; and

WHEREAS, the Council, having been advised of these compensation issues, now desires to amend Ordinance 2024-23 regarding part-time Event Security employee compensation to bring them more in line with the surrounding area and in order to hire and retain the personnel needed;

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart, Lake County, Indiana as follows:

SECTION ONE: That Ordinance 2024-23 be amended as follows:

<u>Part Time Positions:</u>	<u>Fund/Account #</u>	<u>Minimum</u>	<u>Midpoint</u>	<u>Maximum</u>
Event Security (Part-Time)	2530 033 11.011	\$ 12.00/hour	\$26.00/hour	\$ 40.00/hour

SECTION TWO: This Ordinance shall be in full force and effect after its passage by the Common Council and approval by the Mayor.

SECTION THREE: All other provisions of Ordinance 2024-23 and any amendments thereto shall remain in full force and effect.
