3 **ORDINANCE NO. 2014 - 10**

5 **An Ordinance Creating the Hobart Redevelopment Authority**

7 WHEREAS, the Common Council (“Council”) of the City of Hobart (“City”) having
8 previously established a Department of Redevelopment, has determined that it is in the best
9 interest of the City to create a Redevelopment Authority (“RDA”), as allowed by law, for the
10 purpose, among others, of financing, constructing, and leasing local public improvements to the
11 Redevelopment Commission (“RDC”) of the City, previously created and in existence; and
12

13 WHEREAS, there is currently under development a project to install sanitary sewers in a
14 portion of the 61st Avenue right-of-way in conjunction with Phase III of the 61st Avenue
15 Improvement Project, along Wisconsin Street right-of-way from 61st Avenue north to 10th Street,
16 and additional sewers extending South from 61st Avenue along Wisconsin Street, extended, to a
17 point North of the Enbridge pipeline, then East to State Road 51 (“the 61st Avenue Sewer
18 Project”); and
19

20 WHEREAS, the project will be financed by the issuance of a bond by said RDA which
21 will lease the Sewer Project to the RDC, with the approval of the Council, the RDC making lease
22 payments to the RDA from Tax Increment Financing (“TIF”) Revenues, and the RDA using said
23 lease payments to amortize said bond; and

25 WHEREAS, the RDA is intended to constitute a separate body corporate and politic,
26 available for other project financings in conjunction with the RDC, as needed, and its creation
27 shall allow the RDC flexibility in financing the City projects administered by it, both now and in
28 the future; and
29

30 WHEREAS, the Council now desires to create said RDA through the adoption of this
31 Ordinance.

33 THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart,
34 Indiana as follows:
35

36 *SECTION ONE.* The Municipal Code of the City of Hobart, Indiana
37 (“Code”) is hereby amended to add, in Chapter 31, entitled “CITY
38 ORGANIZATIONS” a new section under the heading “*Department of*
39 *Redevelopment*” to be designated §31.036 entitled “REDEVELOPMENT
40 AUTHORITY,” as follows:
41

42 §31.036. REDEVELOPMENT AUTHORITY.
43

44 There is hereby created a Hobart Redevelopment Authority
45 as a separate body corporate and politic and as an instrumentality
46 of the City to exercise any power granted to the authority under


1 I.C. 36-7-14.5. The authority shall be under the control of a board
 2 composed of three (3) members, who must be residents of the City
 3 appointed by its executive. A member is entitled to serve a three
 4 (3) year term, and may be reappointed to subsequent terms. If a
 5 vacancy occurs on the board, the executive of the City shall fill the
 6 vacancy by appointing a new member for the remainder of the
 7 vacated term. A board member may be removed for cause by the
 8 executive of the City. Each member, before entering upon the
 9 duties of office, must take and subscribe an oath of office under IC
 10 5-4-1, which shall be endorsed upon the certificate of appointment
 11 and filed with the records of the board. A member may not receive
 12 a salary, and no profit or money of the authority inures to the
 13 benefit of a member, all as provided by I.C. §36-7-14.5-8.
 14 Meetings of the board, its quorum, election of officers, the
 15 adoption of rules and by-laws, the purposes, powers and duties of
 16 the authority, and all other matters governing the functioning
 17 thereof shall be in accordance with I.C. 36-7-14.5, or any
 18 subsequent enactment of the General Assembly which may be
 19 applicable. In the event of conflict between the provisions of this
 20 section and the currently applicable enactment of the General
 21 Assembly governing the authority, the provisions of such
 22 enactment shall control.

23 *SECTION TWO:* This ordinance shall become effective upon adoption in
 24 the manner required by law.

25
 26 *SECTION THREE:* All ordinances or portions thereof in effect prior to
 27 the effective date and in conflict with the provisions of this ordinance are hereby
 28 repealed.


