

1 **COMMON COUNCIL OF THE CITY OF HOBART, INDIANA**

3 **ORDINANCE NO. 2014-23**

4
5 **An Ordinance to Amend Ordinance No. 2012-42 Dividing the City of Hobart into**
6 **Five (5) Districts for the Election of Members of the Common Council**

7
8 WHEREAS, the Common Council (“Council”) of the City of Hobart, Indiana (“City”)
9
10 is required by I.C. §36-4-6-4 to enact an Ordinance dividing the City into five (5) districts for
11 the purpose of electing district-based members to the Council; and

12 WHEREAS, the Council, by the enactment of its Ordinance Number 2012-42 on
13 December 5, 2012, prescribed new boundaries for said districts to be used in the City elections to
14 be held in 2015; and

15 WHEREAS, a scrivener’s error was discovered in the legal description of one of the
16 districts contained in Ordinance No. 2012-42, namely District Four; and

17 WHEREAS, the Council, through this ordinance, desires to correct said legal description
18 and to give effect to same *nunc pro tunc*.

19 THEREFORE, BE IT ORDAINED by the Common Council of the City of Hobart,
20 Indiana as follows:

21 **SECTION ONE.** The Municipal Code of the City of Hobart is hereby
22 amended by striking out all of the language contained in §11.01 (A)(4) thereof
23 and inserting in lieu thereof the following new language:

25 (4) Common Council District Four is described as
26 follows:

28 Beginning at the intersection of Mississippi Street and 61st
29 Avenue, thence East along the centerlines of 61st Avenue and 61st
30 Avenue extended to the centerline of Deep River, thence
31 Northwesterly along the centerline of Deep River to the centerline
32 of Bracken Road, thence Easterly along the centerline of Bracken
33 Road to centerline of Wisconsin Street, thence North along the
34 centerline of Wisconsin Street to the centerline of 10th Street,

1 thence West along the centerline of 10th Street to the centerline of
2 Decatur Street, thence Southerly along the centerline of Decatur
3 Street to the centerline of Deep River, thence in a Northward
4 direction along the centerline of Deep River to the center of Lake
5 George, thence Northeasterly along the centerline of Lake George
6 to the centerline of Wisconsin Street, thence North along the
7 centerline of Wisconsin Street to the centerline of Norfolk
8 Southern (formerly Norfolk Western) Railroad, thence Easterly
9 along the centerline of the Norfolk Southern Railroad to centerline
10 of Ash Street, thence North along the centerlines of Ash Street and
11 Ash Street extended to the centerline of Cleveland Avenue, thence
12 East along the centerlines of Cleveland Avenue, Cleveland Avenue
13 extended and Cleveland Avenue to the centerline of Beverly
14 Boulevard, thence Northeasterly along the centerline of Beverly
15 Boulevard to the centerline of Old Ridge Road, thence Westerly
16 along the centerline of Old Ridge Road to the centerline of Ash
17 Street, thence North along the centerlines of Ash Street and Ash
18 Street extended to the centerline of the CSX Railroad (formerly
19 Penn Central Railroad), thence Westerly along the centerline of the
20 CSX Railroad to the centerline of Wisconsin Street, thence South
21 along the centerline of Wisconsin Street to the centerline of
22 Cleveland Avenue, thence West along the centerline of Cleveland
23 Avenue to the centerline of Wabash Street, thence South along the
24 centerline of Wabash Street to the centerline of the Norfolk
25 Southern Railroad (formerly Norfolk Western Railroad), thence
26 Northwesterly along the Norfolk Southern Railroad to the
27 centerline of Liverpool Road, thence South, West, Southwesterly,
28 West and South along the centerline of Liverpool Road to the
29 centerline of 53rd Avenue, thence West along the centerline of 53rd
30 Avenue to the centerline of Mississippi Street, thence South along
31 the centerline of Mississippi Street to the intersection of 61st
32 Avenue, which is the point of beginning.

33
34 *SECTION TWO.* This ordinance shall take effect immediately upon its
35 passage in the manner required by law, and shall be given effect as if said amended legal
36 description were included in Ordinance Number 2012-42 as originally enacted. In all
37 other respects, the provisions of Ordinance Number 2012-42 are affirmed.

39 *SECTION THREE:* The Clerk-Treasurer is directed to file a copy of this
40 Ordinance with the Clerk of the Circuit Court of Lake County not later than thirty (30)
41 days after its adoption pursuant to I.C. §36-4-6-4 (n).




To clarify, the only addition to the legal description was at the very end and shown below *in bold italic*:
