**ORDINANCE 2013-10**

**AN ORDINANCE TRANSFERRING APPROPRIATIONS WITHIN THE 2013 BUDGET  
OF THE GENERAL FUND: FIRE DEPARTMENT; and  
the PARK & RECREATION FUND  
IN THE CITY OF HOBART, LAKE COUNTY, INDIANA.**

**WHEREAS**, it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget in certain line items in the General Fund: Fire Department; and the Park & Recreation Fund in the 2013 budget; and
