

**ORDINANCE 2018 - 33**

**AN ORDINANCE AMENDING ORDINANCE 2018-17 OF THE COMMON COUNCIL OF THE CITY OF HOBART, LAKE COUNTY, INDIANA, TO ESTABLISH NEW SALARY CLASSIFICATION IN THE WASTEWATER FUND AND FIXING THE SALARY RANGE FOR SUCH POSITION FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2019 AND ENDING DECEMBER 31, 2019.**

WHEREAS, the Common Council of the City of Hobart, Lake County, Indiana adopted Ordinance 2018-17 on September 5, 2018, fixing the salaries and wages of officers and employees of the City of Hobart for Fiscal Year 2019; and

WHEREAS, the Hobart Sanitary District has created a new hourly position with the title of Lift Station Foreman and a job description and inclusion of the position in the organizational chart for the Lift Station is forthcoming; and

WHEREAS, the Hobart Sanitary District has recommended to the Common Council that the position of Lift Station Foreman be added as a new hourly job classification, amending Ordinance 2018-17 and setting an hourly range of pay of an amount not to exceed \$27.67 per hour; and

WHEREAS, the newly created hourly job classification would result in the transfer of appropriated funds from certain established line items to a new line item without the need for additional appropriations within the Wastewater Fund 2019 budget; and

WHEREAS, the Common Council now desires to amend said Ordinance 2018-17 to create the new hourly job classification and set a wage range for such position as recommended by the Hobart Sanitary District;

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Hobart, Lake County, Indiana as follows:


SECTION ONE: That Ordinance 2018-17 be amended to add the following job classification and hourly wage range in the Wastewater Fund:


	<u>Minimum</u>	<u>Maximum</u>
Lift Station Foreman	\$ 14.90/hour	\$ 27.67/hour

SECTION TWO: The provisions of this Ordinance shall take effect January 1, 2019.

SECTION THREE: All other provisions of Ordinance 2018-17 shall remain in full force and effect.






