RESOLUTION NO. 2020- 13

A Resolution Adopting an Addendum to the April 18, 2019 Joint Interlocal Cooperation Agreement for the Lake County Bridge No. 253, 3rd Street Over Lake George, Between the City of Hobart, Indiana and the Government of Lake County, Indiana

WHEREAS, the Common Council (“Council”) of the City of Hobart, Indiana (“City”) adopted Resolution No. 2018 - 09 on the 18th day of April, 2018 which approved in all respects the “Joint Interlocal Cooperation Agreement for the Lake County Bridge No. 253, 3rd Street over Lake George, between the City of Hobart, Indiana and Lake County, Indiana” (“Interlocal Agreement”), attached hereto and made a part hereof, memorializing the agreement between the City and the Government of Lake County, Indiana (“County”) regarding the performance, management, timing and funding of various aspects of improvements for Lake County Bridge No. 253 (“the Project”) located on 3rd Street over Lake George in the City;


WHEREAS, the Interlocal Agreement contained the provision of funds allocated to the Project by the County to the City to support and contribute to the City’s bridge improvements;


WHEREAS, the County has now decided that in addition to the funds allocated pursuant to the Interlocal Agreement dated the 18th of April, 2018, it would provide an amount of Five Hundred Thousand Dollars (\$500,000.00) to the City for the Project, this additional allocation amends the initial funding amount agreed to in the Interlocal Agreement by an Addendum which is attached hereto and made a part hereof.

THEREFORE, BE IT RESOLVED by the Common Council of the City of Hobart that the Addendum to the said Interlocal Agreement adopted by Resolution on the 18th day of April, 2018 for the additional contribution of funds received from the Government of Lake County by the City of Hobart for the Lake County Bridge #253 3rd Street over Lake George improvements


be adopted and the funds allocated to the City budget for costs exclusively associated with the






This JOINT INTERLOCAL COOPERATION AGREEMENT FOR THE LAKE COUNTY BRIDGE #253, 3RD STREET OVER LAKE GEORGE, BETWEEN THE CITY OF HOBART, INDIANA AND LAKE COUNTY, INDIANA (hereinafter referred to as this "Agreement") is made and entered into this 15th day of July, 2020, in accordance with IC 36-1-7, et seq., as amended from time to time, by and between the CITY OF HOBART, Lake County, Indiana, a Municipal Corporation, by its City Council (hereinafter referred to as "HOBART"), and LAKE COUNTY, INDIANA, a unit of local government, by its BOARD OF COUNTY COMMISSIONERS (hereinafter referred to as "COUNTY"), each a political subdivision and unit organized and operating under the laws of the State of Indiana, as set forth hereinafter:

ADDENDUM


WHEREAS, the estimated cost of Lake County Bridge #253, 3rd Street over Lake George, improvement public works project is Four Million Eight Hundred and Fifty Thousand Dollars (\$4,850,000.00). COUNTY has agreed to contribute an additional Five Hundred Thousand Dollars (\$500,000.00) to HOBART from its county economic development income tax ("CEDIT") funds for the Lake County Bridge #253, 3rd Street over Lake George, improvement public works project.




